## GRANT OF ADHOC RELIEF ALLOWANCE - 2013 @ 10% OF BASIC PAY TO THE CIVIL SERVANTS OF PUNJAB GOVERNMENT

I am directed to state that the Governor of the Punjab has been pleased to sanction an Adhoc Relief Allowance – 2013 @ 10% of basic pay with effect from 1<sup>st</sup> July, 2013 and till further orders to all the Civil Servants of the Punjab Government and contract employees employed against civil posts in Basic Pay Scales on standard terms and conditions of contract appointment. This Allowance is not admissible to contract employees drawing lump-sum pay packages.

- 2. The amount of this Adhoc Relief Allowance 2013:
  - i) will be subject to Income Tax.
  - ii) will be admissible during leave and entire period of LPR except during extra ordinary leave.
  - iii) will not be treated as part of emoluments for the purpose of calculation of pension/gratuity and recovery of House Rent.
  - iv) will not be admissible to the employees during the tenure of their posting/deputation abroad.
  - v) will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.
- 3. The term "Basic Pay" for the purpose of Ad-hoc Relief Allowance 2013 will also include the amount of the personal pay granted on account of annual increment(s)

The above Ad-hoc Relief Allowance - 2013 shall be accommodated from within the budgetary allocation for the year 2013-2014 by the respective Departments and no supplementary grant would be given on this account.
