The Finance Department, Government of the Punjab has received financing from the World Bank towards the cost of the Punjab Resource Improvement & Digital Effectiveness (PRIDE) Program. The main objective of the Program is "to increase Own Source Revenue and improve reliability of resource allocations and access to digital services for people and firms in the province of Punjab". The expected results of the Program correspond with the Government's expenditure framework across three Result Areas which are (i) strengthened budget formulation and fiscal risk management, (ii) increased use of digital technology for delivery of selected public services, and (iii) improved collection of own source revenue.

The Finance Department has established Public Financial Management Unit (PFMU), to implement and coordinate program activities. The Finance Department intends to apply part of the loan proceeds for hiring consulting services.
