AMENDMENT

In the Punjab Pension Fund Rules 2007:


1. In rule 5, clause (a) shall be omitted.
2. In rule 6, after clause (k), the following new clause shall be inserted:
 “(ka) “authorize to merge, acquire or take over management of any other fund or provide investment management or advisory services to any other fund of public entities under Government of the Punjab;”
