- (b) in clause (d); for the words "said Purchase Manual", the expression "Punjab Procurement Rules, 2009" shall be substituted; and

- (ii) in Chapter XV, in Annex-D in para (f), for the words "Purchase Manual" wherever occurring, the expression "the Punjab Procurement Rules, 2009" shall be substituted.
