## Subject: REVISION OF RATES OF DAILY ALLOWANCES ON OFFICIAL DUTY WITHIN THE COUNTRY

In continuation of Finance Department's Notification No.FD.SR-I/9-2/2010 dated 01.01.2013, the Governor of the Punjab is pleased to revise the rates of existing adily allowances admissible to Government officers/officials, while on official duty within the country as under:

2. Specified stations for special rates as notified from time to time are Hyderabad, Islamabad, Karachi, Lahore, Faisalabad, Multan, Peshawar, Quetta, Rawalpindi, Muzaffarabad & Mirpur AJ&K. Henceforth, special rates shall also be

allowed at Sukkur, Bahawalpur, DG Khan, Sargodha, Sialkot, Gujranwala, Murree, & Northern Areas.

- Daily allowance will be admissible only for the actual night(s) at the outstation for which daily allowance is claimed. Where night stop is not involved and if absence from Headquarters exceeds four hours, half daily allowance will be allowed.
- 4. The proposed rates shall not apply where 20 fixed DAs for operational duties are being paid with salary which will be admissible on existing rates.
