

**SUBJECT: LIBERALIZATION OF PENSION RULES.**

In continuation of this department's letter bearing No.FD.SR-III-4-111/89 dated 22.07.1989 on the subject cited above wherein entitlement of family pension to unmarried daughters till their marriage, or their acquiring regular source of income, whichever is earlier, had been mentioned. A question has arisen as to whether a widowed daughter is also covered under the provisions of this circular letter or otherwise?

2. Finance Department has examined the case in consultation of Law & Parliamentary Affairs Department and having approval of the competent authority i.e. Chief Minister, it is hereby clarified that "**a widowed daughter, divorced daughter and un-married sister of government servant**" include for grant of family pension till their re-marriage, or acquiring regular source of income, whichever is earlier.


