Subject:— GRANT OF PH.D/D.SC. ALLOWANCE.

Sir,

I am directed to refer to the subject noted above and to say that the Governor of the Punjab is pleased to decide that w.e.f. 1-7-1988 all Ph.D/D.Sc. Degree holder Civil Servants who have opted for Ph.D/D.Sc. allowance in terms of para 3 of Finance Division O.M No. F-1(97)-R.3/85 dated 26-12-85 (adopted by the Government of Punjab vide Finance Department's No. FD/SRI-9-3/86 dated 17-6-86) as well as those joining service on or after 1st July, 1988 will be allowed Ph.D/D.Sc. allowance of Rs.1500/-p.m.

2- The Ph.D/D.Sc. allowance of Rs.1500/- p.m. would also be admissible as in para 1 to the employes of autonomous bodies/semi autonomous organizations/corporations, who have adopted the scheme of Basic Pay Scales of the Government in toto.

3- It has also been decided that the eligibility of Ph.D allowance will not henceforth be linked with Recruitment Rules and the job assigned to them.

4- The orders contained in this department's circular letter No.FD/SR-1-9-3/86, dated 17-6-1986 and 15-7-1987 regarding grant of qualification allowance to technical/professional employees stand amended to the extent indicated above, w.e.f. 1st July, 1988.

**SUBJECT: GRANT OF Ph.D/D.Sc. ALLOWANCE.**

I am directed to refer to the subject noted above and to state that it has come into the notice of the Government of the Punjab that a frivolous/bogus notification of even number dated 15<sup>th</sup> December, 2010 has been issued wherein the rate of Ph.D/D.Sc. Allowance has been stated to be increased from Rs.5000/- to Rs.10,000/- to equalize these rates and enhance them for language scholars to level equal to the natural and social sciences scholars i.e. Rs.10,000/- for Ph.D and Rs.5000/- for M. Phil w.e.f 19<sup>th</sup> Nov. 2009.

2. In this regard it is necessary to clarify for information of all concerned that the existing rates of the **Ph.D./D.Sc. Allowance i.e. Rs.5000/- per month** sanctioned vide letter of even number dated 19.11.2009 and **Science & Technology Allowance Rs.10,000/- per month** sanctioned vide letter No. FD.SR-I-9-3/86 dated 22.01.2009 are still in fact and no change in this regard has been taken place.


**SUBJECT: GRANT OF Ph.D/D.Sc. ALLOWANCE.**

In supersession of all previous policy letters to the extent of monthly rates regarding grant of Ph.D/D.Sc. Allowance and Science & Technology Allowance issued from time to time, the Competent Authority has now been pleased to enhance the existing rate of the Ph.D./D.Sc. Allowance from Rs.5000/- per month to Rs.10,000/- per month for all subjects across the board w.e.f. 01.07.2012.

2. This would also make entitlement of Special Allowance @ Rs.5000/- per month automatically to M. Phil degree holders on acquiring/possessing M. Phil degree by APUG/EX-PCS/EX-PSS officers as per this department's letter No.FD.SR-I/10-6/85 dated 14.09.1991, as the rate of Special Allowance is 50% of the Ph.D/D.Sc. Allowance. This facility was extended to the teachers of Higher Education Department as well vide this department's letter No.FD.SR-I/10-6/85 dated 19.09.2009.

3. It has further been decided to discontinue the Science & Technology Allowance @ Rs.10,000/- per month forthwith. However, all those drawing this allowance will become entitled for grant of Ph.D/D.Sc. Allowance @ Rs.10,000/- per month w.e.f. 01.07.2012.

4. All other terms & conditions regarding admissibility of the above mentioned allowances shall remain the same.


