Subject: - **GRANT OF TIME SCALE PERSONAL UP-GRADATION.**

I am directed to refer to the subject cited above and to state that a question has arisen as to whether Time Scale Personal Up-gradation is admissible to the employee who is appointed against a post having no upper tier / line of promotion and has two mode of appointment i.e. by initial appointment as well as by promotion.

2. It is clarified that the case of an employee who is **appointed** against a post having no upper tier / line of promotion by initial appointment would be dealt in accordance with para-1(ii) of Finance Department's Notification No.FD.PC.40-12/2017, dated 19.04.2019. Whereas, the case of an employee who is **promoted** against a post, but having no upper tier / line of promotion would be dealt in accordance with para-1(i) of Finance Department's Notification No.FD.PC.40-12/2017, dated 19.04.2019
